Quotations should reach Administrative Officer, National Film Archive of India, Law College Road, Pune - 4 on or before 16.09.2019 latest by 3.00 p.m. in a sealed cover duly superscribed `NIQ for procurement of 4K Ultra HD BluRay Players by NFAI'.

1. Scope of Work

- The bidder needs to submit the details of the proposed 4K Ultra HD BluRay players with all the technical specifications of the same. The technical specification should be in compliance with the parameters asked in **Section 2.**
- The bidder shall provide the Manufacturer Authorization Certificate for the proposed BluRay players.
- The bidder shall be responsible for the entire setup and configuration of the BluRay players.
- The bidder shall be responsible for the maintenance of the player for a period of three years beyond the warranty period of the BluRay players provided to NFAI.

2. Technical Specification

The bidder needs to ensure compliance with all the specification parameters. Non-compliance to any of the specification may lead to disqualification of the bidder.

The other **terms and conditions** for awarding of the work shall be as mentioned below:

- i. Sealed quotation is to be submitted on the Firm / Company letter head
- ii. This Notice for Inviting Quotations (NIQ) is for limited Bidders only and the Bidder who have received a copy of this NIQ shall only be eligible for submitting a response. Bid responses submitted by ineligible Bidders shall not be accepted by NFAI and will be summarily rejected.
- iii. Sealed quotation should reach **Administrative Officer**, **National Film Archive of India**, **Law College Road**, **Pune- 411 004.** on or before 16th September, 2019 up to 3 pm.
- iv. Financial Envelope and technical evaluation envelop should be in a sealed envelope and in-turn should be put in a single large envelope which should be sealed and super-scribed "Quotation for procurement of 4K Ultra HD BluRay players by NFAI".
- v. NFAI also reserved the right to annul this NIQ process without assigning any reason what so ever.
- vi. The quantities mentioned in the financial table are indicative in nature and the actual procurement/work may vary.
- vii. The Bidder will provide one qualified bid response only.
- viii. The time period of the contract shall be one year and the rates quoted shall be valid for the entire duration of the contract period.
- ix. The payment to the Bidder shall be as per the quantity of the work done and basis the unit rate quoted only. No advance payment in any case would be made to the Bidder.
- x. Late submission of response will not be accepted by NFAI. Also, response submission on email will not be entertained.
- xi. The quotations received in unsealed manner will be straight away rejected.
- xii. The rates quoted by the bidder should be inclusive of all applicable taxes.
- xiii. This NIQ is not transferable.
- xiv. NFAI reserves the right to accept or reject any or all bid responses without assigning any reason whatsoever.
- xv. The Bidder shall be responsible for all the cost associated with this response. The bidder shall also be responsible for all the loss or damage caused to any of the material at NFAI owing to negligence on his part.
